### Introduction

Participants of the **Deutsche Bank Equity Plan** who hold their custody account with Deutsche Bank International Limited, Jersey, can register for the web based Online **Equity Plan (EP) System**. This system will allow Participants to view their share balance, and submit sale and transfer instructions. In addition, Participants can verify and issue amendments to their static data.

# Logging In

Following submission and processing of your completed Registration document, the EP System will send you 2 separate emails with Log in instructions. Follow these instructions to complete the Log-in process and gain access to your account.

You will need three pieces of information to log in;

**Primary Email\EP Login ID** = your Primary email address as quoted by you on the Registration Form.

Client number = your 6 digit account number beginning with 36\_\_\_\_ or 37\_\_\_\_

**Password** = your password (or if signing in for the first time, the password provided by email).

#### Forgotten your password

In the event you have forgotten your password, connect to the sign in screen and enter your **Primary Email** and your **Client number** in the appropriate boxes and click on "**Send new password**". The System will then send you an email with instructions to enable you to change your password to gain access.



#### First successful Log in

As part of the process when first signing in you will be required to complete a couple of one-off steps.

- Accept the DB Equity Plan System Terms of Use. These are available in the following location:- <u>www.db-ci.com/EquityPlan</u>.
- Once these are accepted you will arrive at the Personal Details' screen. The first line of your address is displayed. If this is not your current address you can submit a Change of Address using the System.
